## **Eurodoc Elects the New Board in the First Ever Hybrid Annual General Meeting**



Eurodoc's new administrative board for 2021-2022 was elected during the Annual General Meeting (AGM), on 16-17 July 2021. Agnieszka Żyra (KRD, Poland) was elected as Eurodoc President, whilst Sara Pilia (ADI, Italy) was appointed as Vice-President. Agnieszka underlined Eurodoc's commitment to improve conditions for early career researchers (ECRs) and to work together with policymakers, stakeholders and national organisations to address contemporary R&I issues, such as research assessment and Open Science. The outgoing President Giulia Malaguarnera expressed her full trust in the new

## The European Research Council Formally Endorses DORA



European Research Council endorsed the San Francisco Declaration on Research Assessment (<u>DORA</u>). DORA aims to transform research assessment globally and across all disciplines by

promoting practical and robust approaches to evaluating researchers and their work. The signatories pledge to have a transparent evaluation process for funding opportunities, to not use broad metrics such as impact factors and to consider all kinds of research output, including Open Science initiatives.
